April 2009 Update

- Revisions to Appendices P and PP. This instruction includes deletions and revisions to Appendix P as specified below. We have deleted just the section numbered M and renumbered it as Section K. In addition, we added a new Section L, entitled, "Liability Notices and Beneficiary Appeal Rights." Part VII is deleted because this material is now covered in Section II. B., the Traditional Survey, Subtask 5C. L. The following tags are revised: F286 and F309.

June 2009 Update

- Issuance of Revisions to Interpretive Guidance at Several Tags, as Part of Appendix PP, State Operations Manual (SOM), and Training Materials.
- Revisions have been made to Guidance to Surveyors at several Tags in Appendix PP of SOM concerning Quality of Life and Environment.
- Tag F255 (closets) is deleted and regulatory language and Guidance moved to F461.
- A training document with speaker notes for Centers for Medicare & Medicaid Services (CMS) Regional Offices (ROs) and State Survey Agencies (SAs) to use to train surveyors in this revision to the SOM is included in this memorandum. September 2009 Update

- Revisions to Appendix PP – "Interpretive Guidelines for Long-Term Care Facilities," Tag F441." This instruction combines F Tags 441, 442, 443, 444 and 445, and incorporates the guidance into F441.
