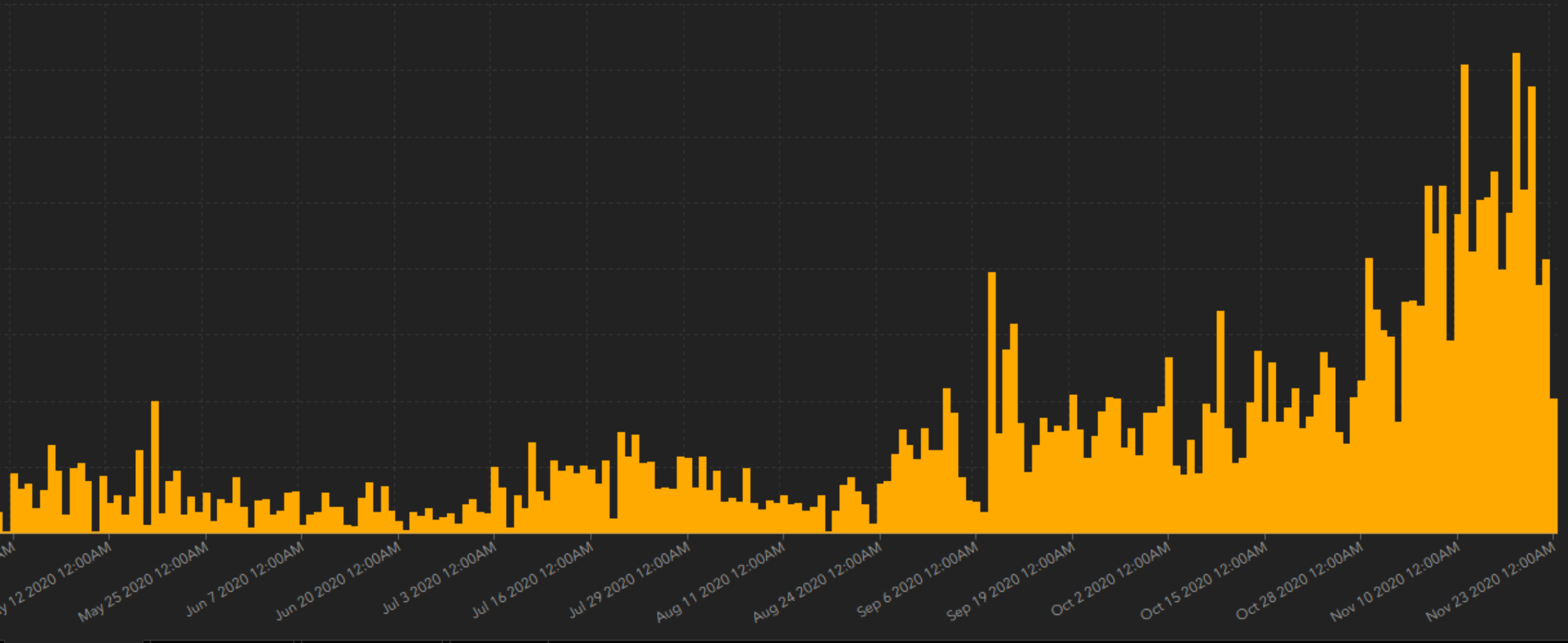

Lancaster County Data – November 23

- 3 additional deaths today – total is now 70
 - 2 women in 90s
 - 1 man in 70s
 - All were hospitalized
- 309 confirmed cases – total is now 14,835
- Weekly Positivity Rate
 - November 15-21 = 27.4%
 - November 22-23 = 28%
- 176 hospitalizations for COVID
 - 78 Lancaster County (6 on ventilators)
 - 98 from other communities (14 on ventilators)
