General Information: Pursuant to Title 92, NAC, Chapter 41,004.05A The school shall have a sufficient number of qualified and experienced instructors in the subject areas for which they are assigned to provide instructional services to students. 004.05A The school shall file with the Department, no later than thirty (30) days following hiring, an instructor's qualification form furnished by the Department. 004.05B The school shall employ instructors who are competent to provide the training contemplated. 004.05C The instructors shall be qualified either by three (3) years of trade or professional experience at a journeyman level, or its equivalent in the trade or specialty to be taught, or a baccalaureate or associate degree in that trade or specialty and one (1) year of trade or professional experience at a journeyman level, or its equivalent in the trade or specialty to be taught, or file a contingency plan approved by the Department whereby the minimum requirements will be met within three (3) years, with the school providing a yearly progress report on the plan. 004.05D If the school prepares students for an occupation that requires a license(s), the instructor shall maintain the appropriate license(s). 41,010.05 Instructors teaching general educational courses in an Associate Degree program, shall hold at least a baccalaureate degree, including adequate preparation in areas the instructors are assigned to teach.
